

## Summary of Capacity Credits assigned by Facility for the 2023 Reserve Capacity Cycle (updated)

For the Capacity Year from 1 October 2025 to 1 October 2026

The Australian Energy Market Operator (AEMO) has assigned Capacity Credits to Facilities that must provide Reserve Capacity into the South West Interconnected System for the 2025-26 Capacity Year. Following the assignment of 4731.617 MW of Certified Reserve Capacity on 05 October 2023, a total of 4716.729 MW of Capacity Credits were assigned.

In accordance with clause 4.20.5A(b) of the Wholesale Electricity Market Rules (WEM Rules), AEMO publishes the following information:

- The Reserve Capacity Requirement (RCR) is 5,543 MW.
- AEMO has assigned 4,516.729 MW of Capacity Credits to eligible Facilities under clause 4.20.5A(aA) of the WEM Rules. Eligible Facilities comprise:
  - Facilities for which no Reserve Capacity Security was required to be provided (4444.904 MW), and
  - Demand Side Programmes (71.825 MW).
- AEMO has determined that the RCR has not been met or exceeded with the Capacity Credits assigned to eligible Facilities.
