General Comments Does your organisation support AEMO's assessment of the proposal? If no, please specify areas in which your organisation disputes AEMO's assessment (include IIR section reference number) of the proposal and include information that supports your organisation's rationale why you do not support AEMO's assessment.	Broadly AGL supports AEMO's assessment, except in relation to the management oh HV Zone changes. AGL Notes that the only discussion on the matter of dynamic HVZs that has been had is between AEMO and the Distribution Networks, although retailers are users of this information. AGL notes that AEMO has proposed that AGL raises a GMI on the issues of retailer notification of HVZ changes. AGL does not accept this response as acceptable. This initiative is being driven by AEMO and to ignore issues raised by one key sector of the gas market and then ask that that sector to identify a change, without having been involved in the discussions and without clarity on the magnitude or frequency of change seems to be a very poor outcome, which is most likely to lead to downstream issues and likely additional cost on the industry.
