1.0 WELCOME, INTRODUCTION and APOLOGIES – Emily Brodie (AEMO) – Slide 1 to 2

Attendees were welcomed to the seventh Procedures Working Group meeting.

2.0 TNSP NEGATIVE SETTLEMENTS RESIDUE PROCEDURE AMENDMENTS— Dimi Botha (AEMO) – Slide 3 to 7

AEMO presented the 5MS related changes to the NEM Transmission Network Service Provider (TNSP) Negative Settlements Residue Procedure, noting that the amendments are administrative with no requirement for Rules consultation.

Consultation is proposed to commence on 1 April 2019, and the final procedure and report is expected for publication on 14 June. AEMO proposed consulting on this procedure through direct engagement with TNSPs through email given that it is only relevant to TNSPs.

The PWG was invited to provide feedback on the proposed consultation approach.

Action 7.2.1: PWG to provide feedback on TNSP Negative Settlements Residue Procedure consultation approach.

3.0 MINUTES & ACTIONS FROM PREVIOUS MEETING – Emily Brodie (AEMO) – Slide 8 to 11

The actions from meeting six have been reviewed and updated. Please refer to the meeting pack and list below for more details.

AEMO advised participants that a consolidated AEMO Retail meeting calendar is under development. This calendar will provide visibility of all 5MS meetings and key dates for other AEMO Retail forums. A consultation calendar is also being drawn together to show the consultation dates for Retail procedures over the next 6-12 months.

Action 7.3.1: AEMO to circulate meetings calendar and consultation calendar when available.

4.0 5MS PROGRAM UPDATE – Graeme Windley (AEMO) – Slide 12 to 16

AEMO presented a high-level transition plan for Dispatch and Bidding, Metering and Settlement systems. These included key milestones on procedure updates, the industry development schedule, AEMOs integration plan and the stakeholder engagement forums. AEMO noted that these plans have also been presented at Program Consultative Forum (PCF).

AEMO noted that the establishment of an industry readiness working group is under consideration to be brought forward from February 2020 to mid-2019. AEMO is currently working with the PCF to progress this matter.

5.0 PROCEDURES WORKSTREAM UPDATE, INCLUDING FOCUS GROUP UPDATES – Emily Brodie (AEMO) – Slide 17 to 24

AEMO reiterated that pre-consultation activities including PWG engagement and circulation of High-Level Impact Assessments are intended as early engagement between AEMO and the 5MS working groups. Commencement of the formal consultation occurs when the Notice of Consultation is published on AEMO's website. Formal submissions to the consultation are required for feedback to be considered in the draft and final determinations.

AMEO noted that a 5MS Webinar targeted to small generators will be organised over the coming weeks through the Clean Energy Council. More information will be provided over the next few days to relevant stakeholders.

AEMO reminded participants that a dedicated 5MS web location to access 5MS specific consultations has been launched. This website provides a summary of key dates and materials for each work package. The actions log is also now online to coordinate issues and actions coming out of the 5MS program.

AEMO reminded participants that submissions for the NEM Settlement Revisions Policy consultation will be due Friday 22 February 2019.

6.0 AUCTION PARTICIPATION AGREEMENT (APA) AMENDMENTS – Austin Tan (AEMO) – Slide 25 to 28

AEMO presented the 5MS related changes to the Auction Participation Agreement (APA), noting that the amendments do not impact the operations of Settlement Residue Auctions (SRA).

Consultation on this procedure will follow the Rules consultation process, and is proposed to commence on 22 March 2019. The final procedure and report are expected for publication on 5 August 2019.

The PWG was invited to provide feedback on the proposed consultation approach.

Action 7.6.1: PWG to provide feedback on Auction Participation Agreement consultation approach

7.0 PRUDENTIAL PROCEDURES AMENDMMENTS – Austin Tan (AEMO) – Slide 29 to 30

AEMO noted that first round consultation on the NEM Settlement Estimates Policy has concluded. Second round consultation will commence on 19 February 2019.

Submissions to the reallocation procedures consultation (EDOR and SOOR) is now closed. AEMO will publish the final procedures and report in late February 2019.



Consultation on the Credit Limit Procedures (CLP) is scheduled to commence on 3 April 2019. Only one round of consultation is proposed given the administrative nature of the proposed amendments. The PWG is invited to provide feedback on this consultation approach.

8.0 GLOBAL SETTLEMENT PROCEDURES AND GUIDES – Austin Tan (AEMO) – Slide 31 – 32

AEMO noted that the final Global Settlement rule introduces new obligations for AEMO to publish UFE information for reconciliation purposes, and also publish information on UFE trends to facilitate the reduction of UFE.

Both these new requirements will require new procedures or guides to be developed as required by the Rules. AEMO noted that the due date to develop these documents for UFE publication and UFE trends reporting are 1 July 2021 and 1 December 2022 respectively. AEMO is currently working to understand these requirements internally and will consult with the PWG and Focus Groups as relevant.

9.0 METERING PACKAGE 1 UPDATE - David Ripper (AEMO) - Slide 33 to 39

AEMO received 15 submissions including two late submissions from Retailers, LNSPs, Metering Providers, Meter Data Providers and intending participants.

AEMO presented its analysis and conclusion on the three material issues, as identified below. More information is available in the meeting pack.

- The proposed profiling approach for 15 and 30-minute interval meters
- · Changes to the delivery of meter data to AEMO
- Industry standard optical port performance and the volume of metering data stored in a metering installation

AEMO noted that there will be effective date mismatchs for some procedures in Package 2 due to the commencement dates of 5MS and Global Settlement (1 July 2021 and 6 February 2022 respectively). After consulting with AEMO's legal team, the current approach is to publish two change-marked procedures where version one includes 5MS changes, and version 2 leverages the clean version 1 document to then include Global Settlement changes.

AEMO noted that Metering Package 3 does not include any Rules consultation documents, and is scheduled to be published for comment in April 2019.

A participant raised concerns regarding participant data provision requirements and AEMO publication requirements that come into effect concurrently on the commencement date. AEMO noted that this issue is currently being discussed internally and will advise of the PWG on the outcome.



A participant requested for a new call for nominations for the next Metering Focus Group given that this session may cover different content and require different expertise.

ACTION 7.9.1: AEMO to advise PWG on outcome of investigations relating to participant data provision requirements and AEMO publication requirements that come into effect concurrently on the commencement date.

ACTION 7.9.2: AEMO to circulate formal invitation for Metering Focus Group and consider a new call for nominations.

10.0 RECONCILATION SUPPORT - Blaine Miner (AEMO) - Slide 40 to 41

AEMO highlighted that it has been considering the level of reconciliation support needed in a 5MS/Global Settlement environment, and is currently considering any opportunities that may exist in enhancing the current level of support being provided. A workshop hosted by AEMO for the industry focusing on reconciliation is currently under consideration.

ACTION 7.10.1: PWG to advise AEMO on level of interest in a reconciliation and profiling workshop, and also propose any relevant agenda items.

11.0 SPOT MARKET OPERATIONS TIMETABLE CONSULTATION – Michael Sanders – Slide 42 to 43

AEMO presented 5MS related amendments to the Spot Market Operations Timetable, noting that AEMO does not expect the consultation to be complicated because of the contents of the timetable are based on the content of the rules. AEMO noted that this package will be discussed at the Dispatch Focus Group on Friday 15 February 2019.

This consultation will follow the Rules consultation process and will commence in Q1 2019.

12.0 DISPATCH MISCELLANEOUS PACKAGE - Michael Sanders - Slide 44 to 45

AEMO highlighted amendments to the Dispatch Miscellaneous Package, noting that majority of the changes are administrative.

AEMO will share marked-up copies of these procedures with the PWG for comment.

ACTION 7.12.1: AEMO to share marked-up copies of the Dispatch Miscellaneous Package with the PWG for comment.

13.0 GENERAL QUESTIONS – Emily Brodie (AEMO) – Slide 46

Energy Australia agreed that AEMO's proposal to include Average Daily Load (ADL) values for each NMI in the NMI List reports that are sent to ROLRs. AEMO to assess technical feasibility to add ADL to NMI List reports and change NEM ROLR Procedures: Part A to specify inclusion of ADL in NMI List reports.

In response to a participant query, AEMO clarified that the concept of a local retailer will be retained for embedded networks.



A participant noted that their systems will be designed and developed according to requirements based on the finalised AEMO procedures. It was raised as a concern that any subsequent requirements and amendments from any future readiness work might result in industry wide system changes. AEMO advised that this is a recognised risk and is already captured in the industry risk register.
