AEMO Competition Law Meeting Protocol

AEMO is committed to complying with all applicable laws, including the Competition and Consumer Act 2010 (CCA). In any dealings with AEMO regarding proposed reforms or other initiatives, all participants agree to adhere to the CCA at all times and to comply with this Protocol. Participants must arrange for their representatives to be briefed on competition law risks and obligations.

Participants in AEMO discussions must:

- 1. Ensure that discussions are limited to the matters contemplated by the agenda for the discussion
- 2. Make independent and unilateral decisions about their commercial positions and approach in relation to the matters under discussion with AEMO
- 3. Immediately and clearly raise an objection with AEMO or the Chair of the meeting if a matter is discussed that the participant is concerned may give rise to competition law risks or a breach of this Protocol

Participants in AEMO meetings **must not** discuss or agree on the following topics:

- 1. Which customers they will supply or market to
- 2. The price or other terms at which Participants will supply
- 3. Bids or tenders, including the nature of a bid that a Participant intends to make or whether the Participant will participate in the bid
- 4. Which suppliers Participants will acquire from (or the price or other terms on which they acquire goods or services)
- 5. Refusing to supply a person or company access to any products, services or inputs they require

Under no circumstances must Participants share Competitively Sensitive Information. Competitively Sensitive Information means confidential information relating to a Participant which if disclosed to a competitor could affect its current or future commercial strategies, such as pricing information, customer terms and conditions, supply terms and conditions, sales, marketing or procurement strategies, product development, margins, costs, capacity or production planning.



Single BUT release agreed, incorporating 4 weeks Industry Test. Documentation included as part of MSATS release 47.2

AEMO development (MSDR, CDR Phase 1, B2Bv3.7) on track.

MSDR Data Transition Table finalised via MSDR Focus Group, updates will be incorporated as required.

Industry Test approach delayed to incorporate BUT and CDR approaches. Industry testing proposed for all capability releases for November release.

CDR Phase 1 available to support commencement of industry test for impacted retailers from 27/7 with DERR and Standing Data APIs initially.

AEMO development and Testing on track for commencement of BUT Industry test from 2/8 (scheduled deployment date).

AEMO

- The MSDR Focus Group met on Monday 20 June 2022
- Items of interest:
 - Confirmed BUT Delivery Approach
 - · Option 2 (single Release approach) has been endorsed by the MSDR FG and the Implementation Forum
 - To accommodate the Industry's request to have 4 weeks of industry testing, AEMO is proposing to:
 - Bring forward the PRE-PROD date to 02-AUG-22
 - Schedule the PROD date to 31-AUG-22
 - Blind Scripts Update
 - · Industry to review the circulated 'MSDR Scripted updates.xlsx' for comment and ultimate agreement
 - AEMO will develop and test the proposed blind update scripts based on Step 1
 - MSDR Data Transition Table Update
 - Version 1.0 of the Table is now considered 'final'
 - Acknowledging that further changes will likely be required during the transition period
 - · Next steps: Discuss, schedule and coordinate transitional activities
 - Provision of Address Details
 - 11 LNSPs have requested AEMO to undertake targeted extracts (5 variations) of MSATS NMI Standing data to assist with their transition from unstructured to structured addresses
 - Requested extracts expected to be provided by AEMO to LNSPs by 24 June 2022, where requested
 - LNSP SIPF Update Plans
 - All LNSPs have now provided updated SIPF standing data update plans to AEMO
 - Over 95% of SIPF updates are currently planned to occur by the end of Oct 2022
 - Next Steps: Confirm BUT and C1 Report row limits
- Next meeting scheduled for Monday 18 July 2022

Industry Testing Approach November Release

- Purpose:
 - Agree approaches to be implemented for 3 capability releases for November 22:
 - CDR Phase 1
 - BUT capability (SIPF)
 - November 7 go-live
 - Establish testing support arrangements for each release
 - Support participant planning of their testing approach
- Overall Approach
 - No Market Trial planned for this release
 - Industry Testing proposed for all 3 capability releases
 - Issues identified during industry tests to be raised via support hub and will be directed to appropriate team to address
 - No Pre-prod Data refresh proposed:
 - Settlement processes not impacted by November release





Approach: Industry test for 3 retailers impacted by CDR phase 1

Outline:

- Participants responsible for their own test scenarios and execution in line with overall CDR requirements
- AEMO support for queries, issues during Industry test period
- MDPs may be requested to support to allow generation of metering data for CDR test purposes
- No open industry Q&A session support provided directly to 3 retailers impacted by phase 1 release
- Issues to be raised via support hub





- Approach: Industry Testing
- Outline:
 - Participants to establish bi-lateral arrangements / timings as required
 - AEMO to schedule ITWG session for Industry planning / questions (Late July)
 - Please provide nominations for ITWG via <u>GSMSDR@aemo.com.au</u> by 5th July
 - AEMO to support twice weekly Q&A session during Industry test period
 - Issues to be logged via normal Help Desk practice
 - Open (AEMO) issues communicated prior to go-live

November Release



- Approach: Industry Testing for all capability for 7th November release
- Outline:
 - Industry test period to reflect pre and post cutover environment
 - AEMO deployment included in test scope
 - Timing of Blind Updates Scripts deployment to be included overall approach
 - Participants responsible for own and bi-lateral testing setup
 - Some co-ordination with MDPs for metering data for CDR may be required
 - ITWG to be convened (August) to agree timings and approach for test period for Nov 7 release
 - Twice weekly Q&A sessions for industry support during Industry Test period
 - AEMO to advise open issues (if any) prior to go-live
