3 Approach for August – October Testing

Aggregated Dispatch Conformance (ADC) approach

- AEMO advised that industry test period for ADC is scheduled to commence from 10 July to 8 August 2023.
 AEMO will confirm on 3 July.
- <u>Post Meeting Note</u> AEMO has communicated that to support set up of BESS and existing ADC
 Aggregates post software deployment Industry test will be available for those participants from 14th July.
- AEMO will notify industry participants when they can commence testing the ADC functions in Pre-prod and
 in addition, will hold bi-weekly Q&A sessions with participants to support industry test and discuss any
 issues encountered. Invitations to be sent this week.
- AEMO provided an ADC industry test timeline and scope. Further information is available on slides 10 and
 11 of the accompanying slide pack.

Fast Frequency Response (FFR) Approach

- AEMO outlined indicative dates for FFR industry testing for August 2023 and is available on slide 13 of the accompanying slide pack.
- AEMO will hold recurring Q&A sessions commencing from 9 August, inclusive of overview of issues/defects.
- AEMO will communicate to participants about settlement runs in the Pre-prod environment and will
 manage issues found during industry testing.

MT PASA Approach

- AEMO advised that industry test period for MT PASA will commence from 28 August to 2 October 2023.
- AEMO will hold recurring Q&A sessions with participants to support industry test and discuss any issues encountered.
- AEMO provided a MT PASA industry test timeline with further information available on slide 18 of the accompanying slide pack.

5MLP Approach

- AEMO advised that industry test period for 5MLP will commence from 4 September to 28 September 2023 and outlined the approach.
- AEMO will hold recurring Q&A sessions with participants to support industry testing and discuss any issues
 encountered.
- AEMO provided a 5MLP industry test timeline with further information available on slide 21 of the accompanying slide pack.
