Meeting Notes (red text highlights action items)

1. Market Trial planning

Tui Grant updated the ITWG on Market Trial planning:

- Workbook version 0.6 was circulated yesterday (27 July) as part of the meeting pack. This has been changing constantly as participants update when they are able to start testing.
- Current version requires a few updates feedback from some participants and 2 additional retailers to be added in.
- From next week AEMO will circulate the workbook on Mon, Weds and Fri with the date in the filename.
- Status of cycle 1 week 1: 7 retailers, 8 LNSPs and 109 tests.
- A number of MCs have now been set-up in MSATS pre-production so Retailers and MCs can now negotiate their testing partnerships:
 - Retailers and MCs to update the Base MC Churn tab:
 - Populate the MC, MPB, MPC, MDP participant IDs
 - Populate the MC 'ready to commence' in column G
- Cycle 1 tests steps have been populated:
 - Test steps have been set up to be descriptive, not perspective, as there are a number of different ways to complete a process.
 - Test steps have been set up for maximum coverage so aim was to include all possible processes, if your business does not undertake a step then set it to N/A.
 - E.g. for notified party, QC will include all roles and initiating tester is expected to N/A or pass as appropriate.
 - Participants are requested to review all their test steps and N/A any test steps that are not relevant. Also to let AEMO know if there are any test steps missing or out of order.
- C&I tests receiving test party has not been populated. Participants asked to review the C&I tab and populate test party in the workbook.
- Cycle 2 test steps have been populated. Participants asked to review Cycle 2 test steps and provide any feedback to AEMO.

- Cycle 3 no new scenarios are currently proposed participants can propose new tests.
- Participants can commence data set-up:
 - Initiating party to identify data (NMIs) for each test scenario and enter into HP SaaS QC. Recommend that a set of data be identified for each scenario rather than just one NMI. For each NMI identified, each role needs to be recorded (e.g. screen shot) to resolve any future testing issues.
 - Where role changes are required (RP from FRMP to MC), then the bulk change tool can be used for a sample of NMIs. AEMO will send the bulk change tool spreadsheet. Participants to populate and return if they wish for the tool to be used.
- Test execution and reporting
 - HP SaaS QC is set-up in folders for the initiating party (Retailer), which makes it difficult for other parties (e.g. Distributors) to find the next test step.
 - AEMO will set-up a report that will show every scenario the last test passed and who needs to do the next steps.
 - Planned execution date can be found in the test workbook and in HP SaaS QC.
- Daily meetings:
 - In cycle 1 week 1 we only have 15 participants so we will have one daily meeting for all participants.
 - As numbers increase we will have multiple daily meetings with different groups of participants, and at least one meeting a week with all participants at once.
- Issue resolution:
 - o Jemena questioned how issues will be resolved during industry testing.
 - AEMO noted that issues should be raised during the daily meeting, and they can be emailed to the POC-ITWG mailing list at any time.
 - o Issues related to procedures will be escalated to the relevant procedures working group.
 - Whilst the procedures is working on the issue the testing group can do what is practicable to progress testing. A defect will be opened to track the resolution of the issue.
 - Note that the POC-PCF has an open risk on this matter and is working on a process to ensure timely resolution to issues raised during industry testing.

Other discussion points:

- During phase 2 some participants have noted that retailers need to clear out their stop files. Retailers to ensure stop files are cleared prior to start of Market Trial.
- Citipower/Powercor noted that they intend on importing production meter data reads during the Market Trial period. This will result in participants' MSATS inboxes receiving reads. Participants to respond to AEMO or CitiPower/Powecor if they foresee any issues with this.
