# Meeting Notes **(red text highlights action items)**

## 1. Industry Test Plan (EN/MC) (version 0.3)

- AEMO presented the third draft of the Industry Test Plan for EN/MC – highlighted changes included additional milestones for the test planning, update to the objective, test data section expanded, data refresh details added.
- Questions and comments from the ITWG at the meeting included:
  - Section 2 – Milestones – participants questioned whether HP SaaS QC licences will be issued for all participants on 28 April or just those registered in the EN/MC test phase. AEMO clarified that this refers to EN/MC test participants only, however AEMO will target to issue all licences by the 12 May ITWG.
- **Participants requested to send feedback to the Industry Test Plan (EN/MC) draft version 0.3 by COB Wednesday 3 May 2017.**

## 2. Industry Test (EN/MC) Workbook (version 0.4)

- AEMO presented the Industry Test (EN/MC) Workbook version 0.4
- This varied from the version 0.3 sent with the meeting pack to include:
  - List of participants registered to participate in phase 1 EN/MC testing.
  - Section for participants to select which scenarios they intend to test.
  - Section for participants to select preferred testing partners.
  - Durations added to test steps.
  - Cycle dates and draft test calendar for cycle 1.
- **AEMO to circulate the Industry Test (EN/MC) Workbook version 0.4 to EN/MC test participants after the meeting.**
- **EN/MC test participants to review the workbook, select their scenarios and test partners (using the filters) by COB Wednesday 3 May 2017.**
- **AEMO to set up an EN/MC test planning meeting on Tuesday 9 May 2017 to discuss the next version of the workbook with participant feedback.**
