<p>In 2012, the aseXML standards working group (ASWG) amended the aseXML schema to include the use of duplicate address attributes within B2B and B2M transactions across the VIC, SA, and QLD retail gas markets.</p>	<p>This project removes the aseXML schema duplicate address attributes (flat type, street type) with the adoption of enumerations file version 7 across VIC, SA, QLD, and NSW-ACT retail gas markets, including B2B transactions from the Gas Foundation Hub, and gas retail aseXML certification service.</p>
