# **POWER OF CHOICE PROCEDURE CHANGES (PACKAGE 3)**

### Date of Notice: 19 May 2017

This notice informs all Registered Participants and interested parties (**Consulted Persons**) that AEMO is conducting an as built consultation on AEMO Procedures which have been amended in the Power of Choice Procedure changes in Package 1 and Package 2 as a result of the Competition in Metering, Embedded Networks and Meter Replacement Processes rule changes (**Amending Rules**).

This consultation is being conducted in accordance with the Rules consultation requirements detailed in rule 8.9 of the NER.

If appropriate, meetings may be held jointly with other Consulted Persons. Please note that, subject to confidentiality restrictions, details of matters discussed at a meeting may be made available to other Consulted Persons.

Submissions in response to this Notice of First Stage of Rules Consultation should reach AEMO by 5.00pm AEST on 27 June 2017.

AEMO may consider late submissions, but is not obliged to do so. Late submissions should explain:
