

NOTICE OF FIRST STAGE OF CONSULTATION

National Electricity Rules – Rule 8.9

1.1. Market Suspension Compensation Methodology Consultation

Date of Notice: 11 February 2019

This notice informs all Registered Participants and interested parties (Consulted Persons) that AEMO is conducting a consultation on the Market Suspension Compensation Methodology¹.

This consultation is being conducted under clause 3.14.5A(h) and 11.111.2 of the National Electricity Rules (NER), in accordance with the Rules consultation requirements detailed in rule 8.9 of the NER.

Matter under Consultation

The matter for consultation is the development of an updated Market Suspension Compensation Methodology. Further details are provided in the Issues Paper published with this notice.
