Systems High-Level Impact

Assessment (HLIA) document

On 6 December 2018, the AEMC made a final rule requiring a move to a Global Settlement framework for the demand side of the wholesale electricity market.

The AEMC made this rule for the following key reasons:

- Improved transparency, leading to fewer settlement disputes and lower levels of Unaccounted for Energy (UFE) over time.
- Competition on equal terms.
- Improved risk allocation driving enhanced incentives.

1.4.2 Five Minute Settlement (5MS)

On 28 November 2017, the AEMC made a final rule to alter the trading interval for the wholesale electricity Spot Market from 30 minutes to five minutes for pricing. The changes are effective from <u>the commencement of the 5MS rule change date</u>.

The AEMC determined the five-minute settlement provides a better price signal for investment in fast response technologies, such as batteries, new gas peaking Generation, and demand response. The alignment of the operational dispatch and financial settlement periods lead to more efficient

bidding, operational decisions, and investment.

The 5MS updates are divided into different workstreams based on functionality as follows:

- Dispatch and Bidding
- Retail and Metering
- Settlements

3 Weekly Planned Tests in 5MS Staging

This chapter details what the participants can expect for Settlements and Billing Staging release on a weekly basis.

3.1 Assumptions

For the staging release, AEMO assumes the following:

- Input data for each settlement, billing run uses production data where possible, with some provisions.
- 5-minute metering data is derived by profiling 30-minute data, using a regional scaling factor calculated from Dispatch results.
- UFE data is **artificially generated** using a random number generator. The generated UFE values are only used to demonstrate system capability and not for any other purpose. Any resemblance to actual UFE values is purely coincidental.
- Due to the use of production metering data, where transmission vs. distribution connected points are not distinguished, DME and therefore UFEA applies to all customer connection points.

Global Settlements planning for the staging environment is currently underway.

- By default, participants are subscribed to the legacy versions of Settlements and Billing Data Model packages.
- Participants must use the Data Interchange portal in the staging environment to subscribe to the updated Data Model packages.
- Directions Compensation and NMAS settlements is not available initially.
- APC and RERT settlements are not exercised in the staging environment.
- Settlements Direct in the staging environment initially uses the production version, transitioning to the 5MS version in May in-line with the Prudentials staging release.

4 Settlements Overview

The Settlements system is part of the Electricity Market Management System that depends on information from Registration and Dispatch systems and calculates amounts owing to or owned by each party including AEMO.

This document details the 5MS and GS changes to the Settlements stream.

4.1 Settlements stream

The Settlements stream includes Settlements, Billing, Invoicing, Reallocations, and Prudentials. This version of the document focuses on the updates to the Settlements and Billing packages.

- Produce Settlements Run Report as per the current process.
- Produce PDF Tax Invoice as per the current process
- Data tables in Data Interchange can be utilised to identify five-minutes vs 30 minutes.

4.4 Mandatory Restrictions compensation calculation

Mandatory Restrictions are a means to control the electricity supply in a region in times of extreme scarcity. The Settlements and Billing systems no longer include Mandatory Restrictions. If necessary, it is calculated manually and included in the statements as a part of the Revision Adjustment. With the five-minute settlements, the Mandatory Restrictions are removed from EMMS.

4.5 Settlements Data Interchange

With the five-minute settlements, the definition of PeriodID changes from 30 minutes (1 to 48) to five minutes (1 to 288).

- Data interchange prior to <u>the commencement of the 5MS rule change date</u> retains a 30-minute PeriodID. The 'Settlement Interval Length' column in the DAYTRACK table of the SETTLEMENT_DATA package determines the granularity.
- Additional indicators are added for 'interval length' to specify the length of an interval in each settlement run.
- A new version of the Electricity data model for 5MS. This will be an optional upgrade as the data model is backwards compatible with the existing 'legacy' version.
- All Settlements results tables in Data Interchange have the two columns (SettlementDate/SettlementRunNo.) as the first elements of the primary key.
- Participants can use 'Interval Length' to compare historical data and with both formats (five-minute and 30-minute).
- Data Model tables containing Mandatory Restrictions (MR) and Smelter Reductions are removed from the Data Interchange. For the list of related tables, see Draft EMMS Technical Specification - 5MS - Data Model v5.00.

4.6 Invoicing

With five-minute settlements, a new flexible invoicing system is available to the market participants. The PDF statement filename structure will remain the same as before: <PARTICIPANTID>_<REPORTNAME>_<BILLINGWEEKSTARTDATE>.RNN

For 5MS, Smelter reduction and Mandatory Restrictions are no longer displayed in the 'Summary of the NEM Transactions' or 'Detailed Transactions' section of any invoice statement. If Mandatory Restrictions component exists, it is calculated manually and included in the statements as a part of the Revision Adjustment.

4.7 Settlement Reports

The NEM Billing system generates the Settlement report in a text file format. With the five-minute settlements, the Billing system includes new DME, UFEA columns in the Settlement report at Transmission Node Identifier (TNI) level. The updated SR report includes new columns as shown below:

The new columns are available from <u>the commencement of the 5MS rule change date</u>. Adjusted Gross Energy (AGE) is available in the Aggregated Energy column and moved from after Description to before DME (MWh). This does not include Unaccounted for Energy (UFE) between <u>the commencement of the 5MS rule change date</u> and <u>the</u> commencement of financial settlement of Global Settlement date.

The new SR Reports removes the following sections:

4.8 Retention period in Settlements Direct

The retention period in Settlements Direct will gradually be extended to three years for the following categories:

- NEM Statements & Correspondence
- QldGas Statements & Correspondence
- SRA Statements & Correspondence
- STTM Statements & Correspondence
- VicGas Statements & Correspondence

The older files will not be back populated. A gradual build-up of the publication retention will take approximately 30 months for a full three-year retention.

4.9 NEM Reports

Due to updates to AEMO's internal systems, the Data Interchange reports for Settlements and Billing display values up to eight decimal places. When the data loads into the participant database table, it truncates, or rounds based on the column definition in the participant database. For example, in the ASPAYMENTS_SUMMARY report, if the value is 200.00123456. In the BILLINGASPAYMENTS table, if the column is defined to 5 decimal places, 200.00124 displays.

4.9.1 Direction <u>Compensation Recovery Amount</u> reports

The <u>Direction Compensation Recovery Amount (CRA)</u> report displays the CRA breakdown amounts by participant category and region ID. With the 5MS Settlements release, this report changes from Excel to CSV file format and is triggered by the posting of a Settlement Statement which includes a direction. The new reports are produced and published on <u>http://www.nemweb.com.au/#directions-reconciliation</u> when a Billing run is posted.

The filename convention for the new files are as follows:

- PUBLIC_BILLING_DIRECT_PROV_CRA_SPLIT_CAT_REG_<BillingWeek>_<Datetime>. CSV – produced when a PRELIM/FINAL run is posted.

Currently, a separate file is produced for each Direction ID. With the new updates, a single file is produced with all Directions in the week.

5 Global Settlements

This section describes the updates for Global Settlements.

5.1 Global Settlements

Global Settlements changes how the unaccounted-for energy (UFE) is calculated and allocated. Currently, based on the total energy consumed in a network, the UFE for a local area is apportioned to participants responsible at the Transmission Connection Point (TCP).

With GS, the UFE is now assigned to each participant in the Distribution Network based on the energy they consume. To facilitate allocation of UFE, from <u>the commencement of</u> <u>the 5MS rule change date</u>, meter data providers (MDPs) provide AEMO Metering Data for all participants and notify AEMO of the consumption of metered loads.

AEMO reports UFE calculation from <u>the commencement of the 5MS rule change date</u> and applies it to AGE calculations from <u>the commencement of financial settlement of</u> <u>Global Settlement date</u>,

5.2 AEMO reports on UFE

In order to comply with the Rules for reporting the UFE, AEMO creates the following reports in the Data interchange as csv files:

5.2.1 Settlement data extract file

UFE information is added to the confidential settlement data extract file. The settlement data extract file is available as a csv file or on the

Data Interchange in the SETCPDATA table. This report now includes the following additional data for each settlement run number, market participant, settlement day, trading interval, and TNI:

- Local Area ID is the geographical area allocated to a Network Service Provider by the authority responsible for administering the Jurisdictional Electricity Legislation in the relevant Participating Jurisdiction.
- DME in MWh is the amount represented by (ME- * DLF) for a Connection Point and Trading Interval where:
- ME- is the amount of electrical energy in MWh flowing at the Connection Point in the trading interval (where the flow is away from the Transmission Network Connection Point to which the Connection Point is assigned)
- DLF is the Distribution Loss Factor applicable at the market Connection Point.

- UFEA in MWh is the allocation of Unaccounted for Energy for a relevant TNI and Trading Interval.
- AGE is the Adjusted Gross Energy in MWh which includes UFEA.

For entries in the SETCPDATA table, the UFE value is published and will contain a value of ZERO (rather than null) if the participant has energy at the TNI but is not subject to allocation of UFE.

This report is private meaning participants only have access to their data.

5.2.2 Local Area UFE Data Extract file

A new data extract report titled Local Area UFE Data Extract available publicly through NEMWEB as a csv file and the Data Interchange in the SETLOCALAREAENERGY and SETLOCALAREATNI tables. This report is produced for each settlement run for a combination of the LA and TI.

This report includes the following details:

- Settlement run number
- Local Area ID
- Settlement date
- Trading Interval (5 minutes) ID
- ADME in MWh is the aggregate of the amounts represented by (ME * DLF) for that trading interval for each Connection Point.
- TME in MWh is the amount of electrical energy flowing at each Transmission Network Connection Point in the local area in the trading interval.
- DDME in MWh is the amount of electrical energy flowing at each of the Distribution Network Connection Points in the local area, connected to an adjacent local area in the trading interval.
- UFE in MWh for the LA and TI

AGE in MWh is the Adjusted Gross Energy for the local area and trading interval which includes UFE.


6 Publishing Direct API Design

The following chapter lists the new and updated Publishing Direct APIs and the request and response structure for the APIs.

6.1 API access

AEMO's Publishing Direct APIs are accessible via MarketNet and the Internet.

The contents of the rest of this document are finalised, the API changes are still under consultation and not definite at this stage.



6.2 API whitelisting

The staging environment requires AEMO to whitelist your public IP address. To have your IP whitelisted, log a call with the Support Hub who will ask you to provide the following details:

1. Participant ID(s)

- 2. Inbound Public IP address or a range of IPs
- 3. SSL Certificate Signing Request (CSR)
- 4. The APIs you want to access

6.5 API authentication and authorisation

API connections use SSL certificates to secure the transport layer ensuring encrypted communication and secure interactions between participant and AEMO's systems. AEMO issues the SSL certificates to participants on request.

API calls are authorised by Basic HTTP authentication using a username and password assigned by the company's Participant Administrator.



From a wholesale energy market system's focus, participants need to:

- Review the changes implemented as part of this Release and assess the impact on their market systems.
- Plan to upgrade their Data Interchange installations to the latest versions to utilise benefits from the new functionality, operate against newly supported platforms, and to maintain ongoing support from AEMO.
- Schedule staff and resources to upgrade their market systems from the implementation of this Release. To maintain systems in line with AEMO's market systems, AEMO recommends upgrading within six months of the implementation date.
- Change their systems prior to the deployment of this Release to ensure they are up to date. AEMO recommends participants' wholesale market systems are compliant with the latest Data Interchange software versions, see Data Interchange Framework and Glossary.

Implementation

8.5 What happens if I do not upgrade?

If participants' systems are compliant with AEMO's supported configuration defined in DI Framework and Glossary, this Release does not impact MMS Data Model systems immediately. Depending on participants' systems, not upgrading may result in the following issues:

• Participant's database does not receive the new fields or tables because the Data Model elements are not created. AEMO encourages participants to make use of the four-week preproduction period, to assess and test any impact to their market systems and business processes. Participants using data replication products critical to their business are strongly advised to participate in the pre-production rollout and testing period.

- Participants not subscribed to the latest versions of files using the Data Subscriptions web application will not receive the new data.
- Content in legacy files may change after deployment of this Release.

If participants have a system dependency on the formats of the non-MMS Data Model reports, they need to manage these dependencies using the detail provided in this technical specification. Participants need to review and assess the impact on their market systems with respect to the changes implemented as part of this Release.
