1 Introduction

Section 3.18 of the National Electricity Rules (NER) authorises AEMO to conduct Settlement Residue Auctions. Clause 3.18.5 requires AEMO to establish a Settlement Residue Committee (SRC). One function of the SRC is to report on the auctions conducted by AEMO (clause 3.18.5(b)(3)). The purpose of this document is to report on the auctions conducted by AEMO on 15 September 2016 and the distribution of residues for 2016 Quarter 3.

Note that all prices quoted in this report exclude GST.

2 Participation

To be eligible as an Auction Participant, Market Customers, Generators and Traders must enter into an Auction Participation Agreement (APA) with AEMO.

Prior to these auctions, 38 APA holders were able to bid at the Auctions and 15 participants lodged bids.¹

3 Auction Conducted

AEMO conducted a single auction covering the twelve quarters on 15 September 2016 as follows.

Figure 1 NSWQLD Clearing Prices




Figure 2 QLDNSW Clearing Prices






Figure 3 SAVIC Clearing Prices




Figure 4 VICSA Clearing Prices







Figure 5 NSWVIC Clearing Prices

5 Inter-Regional Settlement Residue

Table 5 lists the residue payments for 2016 Quarter 3.

In summary for the quarter:

- approximately \$44.22 million of residues was distributed to unit holders
- auction proceeds were approximately \$27.3 million
- total negative residues were approximately \$1.71 million

Negative inter-regional settlement residues (IRSR) are recovered from the receiving Transmission Network Service Provider of the relevant directional interconnector.

6 Notes

The Inter-Regional Residue that has been distributed to unit holders over the last year has significantly increased overall, moving from \$19.4 million in 2015Q4 to \$44.2 million in 2016Q3.

In 2016Q3, it is the VICSA interconnector that represents the majority (68.0% or \$30.0m) of the distributed residue.

At the same time, the overall Auction Proceeds have only increased minimally (except for VICSA which has increased significantly and NSWQLD which has decreased slightly).

Therefore, the overall payout ratio has increased quarter on quarter to 161.9%.
