1 Introduction

Section 3.18 of the National Electricity Rules (the Rules) authorises NEMMCO to conduct Settlement Residue Auctions.

Clause 3.18.5 requires NEMMCO to establish a Settlement Residue Committee (SRC). One function of the SRC is to report on the auctions conducted by NEMMCO (clause 3.18.5(b)(3)).

The purpose of this document is to report on the auctions conducted by NEMMCO on the 16th March 2009 and also to report on the distribution of residues for Quarter 1, 2009.

It should be noted that all prices quoted in this report are exclusive of GST.

2 Participation

To be eligible as an Auction Participant, Market Customers, Generators and Traders, must enter into an Auction Participation Agreement (APA) with NEMMCO.

Prior to these auctions, thirty one (31) Auction Participation Agreement holders were able to bid at the Auctions. Seventeen (17) Participants lodged bids and all were successful in winning at least one unit.

3 Auctions Conducted

NEMMCO conducted a single auction covering the next four quarters on 16th March 2009. The table below indicates the respective tranche portions with the following exception:

- April June 2009 (2009/2) 100% of the available residue on all directional interconnectors has been auctioned.
- July September 2009 (2009/3) 75% of the available residue on all directional interconnectors has been auctioned.
- October December 2009 (2009/4) 50% of the available residue on all directional interconnectors has been auctioned.
- January March 2010 (2010/1) 25% of the available residue on all directional interconnectors has been auctioned.



4.5 Clearing Prices



Clearing Prices - NSWQLD




Clearing Prices - QLDNSW




Clearing Price - SAVIC



Clearing Prices - VICSA




Clearing Prices - NSWVIC







5 Inter- Regional Settlement Residue

The distribution of all residues for quarter 1 (weeks 1 to 13) which was 28 December 2008 to 28 March 2009 has been made and are summarised in the table below. Graphs indicating the variation of accumulated residue with time are also included.

For this quarter approximately \$83.027M of residues was distributed to unit holders. Auction proceeds for this same period were \$59.116M. The total negative residues for the quarter were \$1,576,687.69. \$1.218M residue occurred in week 7 on NSW-VIC interconnector. QLD-NSW interconnector incurred \$27.80k negative residues during week 1 and another \$2.3k in week 10. SA-VIC interconnector accumulated negative residues during weeks 5, 6, 7, 9 and 13 totalling \$327k.

Residue Payments Quarter 1, 2009 (weeks 1 to 13)



7 Conclusion

On the 16th March 2009 NEMMCO conducted an auction for inter-regional residue units arising on the six directional interconnectors (NSWQLD, QLDNSW, NSWVIC, VICNSW, SAVIC and VICSA) for quarters 2, 3, and 4 of 2009 and quarter 1 of 2010.

Seventeen (17) of the thirty one (31) auction participants eligible to bid participated in the auction.

All units offered were sold.
