#### 1. INTRODUCTION

Section 3.18 of the National Electricity Rules (the Rules) authorises AEMO to conduct Settlement Residue Auctions.

Clause 3.18.5 requires AEMO to establish a Settlement Residue Committee (SRC). One function of the SRC is to report on the auctions conducted by AEMO (clause 3.18.5(b)(3)).

The purpose of this document is to report on the auctions conducted by AEMO on the 15<sup>th</sup> June 2009 and also to report on the distribution of residues for Quarter 2, 2009.

It should be noted that all prices quoted in this report are exclusive of GST.

## 2. PARTICIPATION

To be eligible as an Auction Participant, Market Customers, Generators and Traders, must enter into an Auction Participation Agreement (APA) with AEMO.

Prior to these auctions, thirty three (33) Auction Participation Agreement holders were able to bid at the Auctions. Sixteen (16) Participants lodged bids and all were successful in winning at least one unit.

#### 3. AUCTION CONDUCTED

AEMO conducted a single auction covering the next four quarters on 15<sup>th</sup> June 2009. The table below indicates the respective tranche portions with the following exception:

- July September 2009 (2009/3) 100% of the available residue on all directional interconnectors has been auctioned.
- October December 2009 (2009/4) 75% of the available residue on all directional interconnectors has been auctioned.
- January March 2010 (2010/1) 50% of the available residue on all directional interconnectors has been auctioned.
- April June 2010 (2010/2) 25% of the available residue on all directional interconnectors has been auctioned.

## 4. AUCTION RESULTS

This section of the report details the public results for the auction conducted on 15<sup>th</sup> June 2009 for the relevant quarters.

The first four sub-sections of this section illustrate the public results for each of the relevant quarters for which auctions have been conducted. The final sub-section indicates in graphical form the performance of the clearing price.

## **4.1 July – September 2009**

All of the tranches for this quarter have been completed for all unit categories.

Table 4.1 indicates the clearing prices for each tranche for each directional interconnector.

Bold typeface indicates the results for the 15<sup>th</sup> June 2009 Auction.

The purchase payments for this quarter are \$17.157M.

The purchase payments for this quarter are \$3.615M.




### 4.5 Clearing Prices


It should be noted that the vertical scale of each graph has been automatically selected to reflect the range of prices being displayed. As such the scales are not consistent across all graphs.




## **Clearing Prices - QLDNSW**




**Clearing Price - SAVIC** 




**Clearing Prices - VICSA**

## 5. INTER-REGIONAL SETTLEMENT RESIDUE


The distribution of all residues for quarter 2 (weeks 14 to 26) which was 29 March 2009 to 27 June 2009 has been made and are summarised in the table below. Graphs indicating the variation of accumulated residue with time are also included.


**Quarters** 

In summary, for this quarter:

- approximately \$13.9M of residues was distributed to unit holders
- · auction proceeds were approximately \$15.6M, and
- total negative residues were \$1,546

Negative residues of \$1,530 occurred during weeks 21 and 22 on SA-VIC interconnector. The remaining residues occurred on NSW-QLD interconnector in weeks 14 and 20.
