#### 1 Introduction

Section 3.18 of the National Electricity Rules (NER) authorises AEMO to conduct Settlement Residue Auctions. Clause 3.18.5 requires AEMO to establish a Settlement Residue Committee (SRC). One function of the SRC is to report on the auctions conducted by AEMO (clause 3.18.5(b)(3)). The purpose of this document is to report on the auctions conducted by AEMO on 15 December 2010 and the distribution of residues for Quarter 4, 2010.

Note that all prices quoted in this report exclude GST.

### 2 Participation

To be eligible as an Auction Participant, Market Customers, Generators and Traders must enter into an Auction Participation Agreement (APA) with AEMO.

Prior to these auctions, 35 APA holders were able to bid at the Auctions and 16 participants lodged bids.

#### 3 Auction Conducted

AEMO conducted a single auction covering the twelve quarters on 15 December 2010 as follows:






#### Clearing Prices - QLDNSW




#### **Clearing Price - SAVIC**




#### **Clearing Prices - VICSA**

#### 5 Inter-regional Settlement Residue

The distribution of all residues for quarter 4 (weeks 40 to 52) from 26 September 2010 to 25 December 2010 has been made and are summarised in the table below. Graphs indicating the variation of accumulated residue with time are also included.

In summary for the quarter:

- approximately \$18.34M of residues was distributed to unit holders
- auction proceeds were approximately \$32.15M
- total negative residues were approximately \$2.25M

The major occurrences of negative residues were:

- week 43<sup>1</sup>
  - VIC to NSW interconnector accrued approximately \$983k of negative residues
  - QLD to NSW interconnector accrued approximately \$532.9k of negative residues
  - VIC to SA interconnector accrued approximately \$192.4k of negative residues
- week 49<sup>2</sup>
  - VIC to NSW interconnector accrued approximately \$156.8k of negative residues
- week 51<sup>3</sup>
  - QLD to NSW interconnector accrued approximately \$249.9k of negative residues.




