

1 Introduction

1.1 Overview

These are the release notes for the Wholesale Electricity Market Prudential and Settlement Services (WEM PaSS) 2.1 (Build 2.1-817-1). This release fixes a bug that prevented Supplementary Capacity Contract (SCC) payments from being processed in WEM PaSS, along with several internal and external minor bug fixes and improvements that have been addressed.

2 Enablement of Supplementary Capacity Contract payments

A bug was identified which prevented AEMO from processing and settling Supplementary Capacity Contract (SCC) payments in WEM PaSS. This update allows AEMO to process and settle SCC payments to both Rule Participants and non-Rule Participants.

The Formulation has been updated to reflect these changes. Refer to Section 4.9.3 of the WEM Metering, Settlements and Prudential Calculations formulation version 4.2 for changes.

No Market Participant impact is expected.

3 Resolved Issues

In addition to the update above, the following issues have been resolved in this release.

Reference	Summary	Resolution
• PRUD-66	The column width of the Credit Support Register is too narrow for some Participants	Increase the width of the columns.
• PRUD-78	JSON file structure is inconsistent with JSON string structure; therefore, Participants can obtain different results depending on method used	Remove the option to download JSON files from WEMS settlements when selecting <i>Download an Invoice</i>
• AS-6081	There are a number of NMIs which have Standing data and meter data that AEMO settle on which need to be removed	Removal of NMIs from AEMO database
