

1 Introduction

1.1 Overview

These are the release notes for Registration Release 1 (WEMS 4.0-1571-1). This WEMS release includes the changes to the registration system, including the WEMS MPI user interface (https://wems.aemo.com.au/mpi/), as required by the WEM Rules and Post-Amended Rules.

The purpose of these release notes is to present an overview to Rule Participants of the changes to the WEMS MPI user interface for the new registration system.

Note: After Registration Release 1, a new deployment is required to update internal functionality. More details on the subsequent Registration Release 2 to implement an internal patch will be disclosed via Market Message and will not be included release notes.



2 User Management Changes

AEMO has implemented a new role in User Management interface for "Registration (SCED)" and amended the existing role of "Registration" to "Registration (Balancing)". It is accessible by navigating on the main menu in WEM MPI through Configuration > User Management > View Users.

The new roles "Registration (SCED)" and "Registration (Balancing)" allows users to set their access as either "Full Access" or "Read Only" for the new registration system (Registration – SCED) and the existing registration system (Registration – Balancing) respectively.

3 New Registration System

The WEMS home page has been modified to include "Registration (Balancing)" and "Registration (SCED)" tabs to delineate access to registration systems for the Balancing Market and SCED Market (Real-Time Market).

3.1 Registration (SCED)

The Registration (SCED) tab contains online application forms and supporting views for the SCED Market (Real-Time Market) and allows users to:

- register as a Rule Participant;
- register their Facility into the new Facility Classes (existing Facilities registered in the Balancing Market and new Facilities);
- provide or update their Rule Participant registration information; and
- provide or update their Facility registration information.

Registration (SCED) retains most of the functionalities of its predecessor version, Registration (Balancing), and the following sections only outline changes from the previous version.

3.1.1 Market Participant Standing Data

A new application form called Market Participant Standing Data is available under the Market Participant Registration menu, see Figure 3.

The Market Participant Standing Data application form allows Market Participants to update their maximum Loss Factor adjusted quantity of energy that could be consumed during a Trading Interval. This field is required under Appendix 1(a) of the WEM Rules.

3.1.2 Participant Registration Application Forms

Updates to the below application forms have made to be consistent with changes in the Post-Amended Rules.

- Rule Participant Registration
- Rule Participant Deregistration

Rule Participant Registration and Deregistration forms have been modified to apply to the new Rule Participant classes of Market Participant and Network Operator. Options to register as a Market Generator, Market Customer and Ancillary Service Provider have been removed as they are no longer Rule Participant classes in the Post-Amended Rules.

Figure 4 Rule Participant Registration Form





Figure 5 Rule Participant Deregistration Form



3.1.3 Facility Registration

Amendments to the structure of the following Facility views have been made to be consistent with the Post-Amended Rules or columns from the previous views have been removed as they are redundant.

- Facility Summary Table;
- Facility Details; and
- DSP Summary Report

Below are the detailed amendments to the following Facility views:

Facility Summary Table

The Facility Summary Table view only displays Facility Name, Aggregated Facility Status, Facility Class or Non-Dispatchable Load, Date of Registration, and Date of Deregistration.

The previous columns of Facility Owner, Balancing Status, LFAS MW Limit (Down/Up), Intermittent Load Status, Demand Side Management Program, and Associated Demand Side Management Program (DSMP) are no longer available within this view.

Facility Details

The Facility Details view only displays the following sub-sections when you select a Facility:

- Facility List,
- General Information,
- Standing Data; and
- Reserve Capacity.

The additional sub-sections will display based on the applicable Facility Class of the selected Facility:

- NDL Information,
- Separately Certified Component, and
- Facility Technology Type.

The following sub-sections and their contents in the application forms have been updated to be consistent with the Post-Amended Rules:

- · Facility List,
- General Information,
- Standing Data;
- · Reserve Capacity; and
- NDL Information


The following sub-sections and the contents in the application forms have been created to meet the data requirements under the Post-Amended Rules:

- Separately Certified Component, and
- Facility Technology Type.

Note that the Facility Status section has been removed and is not available in the new registration system.

Figure 6 Facility Details view




3.1.4 Facility Deregistration Application Form

The Facility Deregistration form has been amended in the Declaration section to remove a check box that confirmed the payment of the Deregistration Application.

3.1.5 Removed redundant Facility Application Forms

The following Facility applications forms have been removed as they are redundant and not required under the Post-Amended Rules:

- Balancing Declaration

- VSAF Post Trial Decision
- LFAS Registration
- LFAS Registration Parameter Change

3.2 Registration (Balancing)

AEMO has created the Registration (Balancing) tab, see Figure 9, which contains all the information and application forms applicable for the current market. Participants will be able to view and modify registration data or submit registration applications applicable in the Balancing Market up to the day prior to New WEM Commencement Day. Post New WEM Commencement Day, access to the Registration (Balancing) tab will be made read-only.

4 Market Participant Obligations

Please refer to the AEMO's SharePoint (<u>Reformer</u>) for further details of the suggested Rule Participant testing activities and obligations deadlines. Rule Participants are encouraged to perform Registration (SCED) testing in Market Trial (https://wems-mkt.aemo.com.au/mpi) from 31 May 2023.

Be aware that all Registration information will be migrated to the Registration (SCED) interface including existing users' rights, and Rule Participant's associated Facilities will be migrated to candidate Facility status. Rule Participants may request **provisional approvals** from AEMO to register the applicable candidate Facilities in the respective Facility Class.
