## INTERVENTION PRICING METHODOLOGY CONSULTATION

**Date of Notice:** 29 June 2018

This notice informs all Registered Participants and interested parties (**Consulted Persons**) that AEMO is conducting a consultation on the Intervention Pricing Methodology<sup>1</sup>.

This consultation is being conducted under Clause 3.9.3(e) of the National Electricity Rules (**NER**), in accordance with the Rules consultation requirements detailed in clause 8.9 of the NER.

### Matter under Consultation

The consultation considers potential improvements to the Intervention Pricing Methodology in order to minimise anomalous price outcomes during Interventions.

Further details are provided in the Issues Paper published with this notice.

A proposed amended Intervention Pricing Methodology is also published with this Notice.
