

NOTICE OF PROCESS FOR PROPOSED MINOR AMENDMENT

National Electricity Rules – Rule 7.17

B2B Procedures v3.6.2

Date of Notice: 14 May 2021

This Notice informs all Registered Participants, Metering Providers, Metering Data Providers, Embedded Network Managers, Ministers and the AER (Persons) that the IEC is conducting a minor amendment process in respect of the B2B Service Order Procedure v3.6.2

This process is being conducted under 7.17 of the National Electricity Rules (NER).

Relevant Matter

The relevant matter is to correct Table 13 of the B2B Service Order (SO) Procedure v3.6.1. This requires amending 'N' to 'O/N' for the PurposeOfRequest SO field against Metering Service Works Remove Meter and Metering Service Works Install Controlled Load SO types.

This allows for additional purposes of request, e.g. Site Abolishment or a request to install an Additional Meter.

The relevant matter also includes replacing the Figure 3: Proposed new Customer Service sequence for ACT with the updated NMI Allocation Process from EvoEnergy in the B2B Guide.

The Information Exchange Committee (IEC) notes that there are no further changes proposed to the SO Procedure or the other B2B Procedures. The latter will be updated to ensure consistent numbering with the SO Procedure.

The Process

The process is outlined below. Dates are indicative only and subject to change.

AEMO invites written submissions on the relevant matter, including any alternative or additional proposals you consider may better meet the objectives of this process and the national electricity objective in section 7 of the National Electricity Law.



Please identify any parts of your submission that you wish to remain confidential, and explain why. AEMO may still publish that information if it does not consider it to be confidential, but will consult with you before doing so.

Please note that material identified as confidential may be given less weight in the decision-making process than material that is published.

Meetings

In your submission, you may request a meeting with AEMO to discuss the relevant matter, stating why you consider a meeting is necessary or desirable.

If appropriate, meetings may be held jointly with other persons. Subject to confidentiality restrictions, AEMO will generally make details of matters discussed at a meeting available to other persons, and may publish them.

All submissions must be forwarded in electronic format (both pdf and Word). Please send any queries about this process to the same email address.

Submissions received after the closing date and time will not be valid, and AEMO is not obliged to consider them. Any late submissions should explain the reason for lateness and the detriment to you if AEMO does not consider your submission.
