9.1	CATS_REGISTER_IDENTIFIER RegisterID	<ul> <li>Although the Suffix section was amended from the First Stage to align with the approved ICF_029, the RegisterID section has been updated incorrectly and now de-couples the intent of ICF_029. The prescriptive requirements for the Register Identifier are resulting in the need to make unnecessary costly system changes and are not adding value to Market Participants. Hence, the original ICF_029 sought to remove the need to align the Register Identifier to the NMI Suffix, as such AusNet recommends reinstating the original definition.</li> <li>The RegisterID is an identifier used to identify records stored within the CATS_REGISTER_TABLE. A record must be created in the CATS_REGISTER_TABLE for each physical register within a meter.</li> <li>For Accumulation Meters, the RegisterID may reflect any unique identifier. E.g. '1', '01', '11', etc</li> <li>For Interval Meters, the RegisterID may match the content of the 'Suffix' within the CATS_REGISTER_IDENTIFIER table. E.g. 'E1', 'B1', 'Q1', 'K1', etc.</li> <li>The RegisterID is used to identify a data source that is obtained from the meter. A single meter may provide multiple data sources.</li> </ul>
