

# UPDATED CALL FOR SUBMISSIONS ON PROCEDURE CHANGE PROPOSAL

Wholesale Electricity Market Rules – Clause 2.10

## AEPC\_2017\_04: CERTIFICATION OF RESERVE CAPACITY

**Date of Notice: 21 July 2017**

This notice informs all Rule Participants and interested parties (**Consulted Persons**) that, in accordance with clause 2.10.18 of the Wholesale Electricity Market Rules (WEM Rules), AEMO has published a notice of extension on the consultation for the Procedure Change Proposal in respect of the revised Market Procedure: Certification of Reserve Capacity (**Procedure**).

This consultation is being conducted in accordance with the Procedure Change Process detailed in clause 2.10 of the WEM Rules.

### Matter under Consultation

The matters are related to clauses 4.9.10 and 4.28C.15 of the WEM Rules which require AEMO to document the process Market Participants must follow in applying for Certified Reserve Capacity or Early Certified Reserve Capacity, and AEMO must follow in processing those applications, including to assign Certified Reserve Capacity, set Reserve Capacity Obligation Quantities, and approve Early Certified Reserve Capacity.

Further details are provided in the notice of extension published with this call for submissions, the original Procedure Change Proposal and the proposed revised Market Procedure.

### Consultation Process

The consultation process is outlined below. The revised dates are indicative only and subject to change.

### Invitation to Make Submissions

AEMO invites written submissions on this Procedure Change Proposal, including any alternative or additional proposals that you consider may improve the Procedure or better meet the Wholesale Market Objectives in section 122(2) of the Electricity Industry Act 2004 (and clause 1.2.1 of the WEM Rules).

Please identify any parts of your submission that you wish to remain confidential, and explain why. AEMO may still publish that information if it does not consider it to be confidential, but will consult with you before doing so.

### **Meetings**

In your submission, you may request a meeting with AEMO to discuss the Procedure Change Proposal, stating why you consider a meeting is necessary or desirable.

If appropriate, meetings may be held jointly with other Consulted Persons. Subject to confidentiality restrictions, AEMO will generally make details of matters discussed at a meeting available to other Consulted Persons, and may publish them.
