

CALL FOR SUBMISSIONS ON PROCEDURE CHANGE PROPOSAL

Wholesale Electricity Market Rules – Clause 2.10

PC_2017_01 DETERMINATION OF EXPECTED DSM DISPATCH QUANTITY AND DSM ACTIVATION PRICE

Date of Notice: 23 March 2017

This notice informs all Rule Participants and interested parties (**Consulted Persons**) that AEMO has published a Procedure Change Proposal in respect of the Market Procedure: Determination of Expected DSM Dispatch Quantity and DSM Activation Price and is conducting a consultation process in respect of this proposal.

This consultation is being conducted in accordance with the Procedure Change Process detailed in clause 2.10 of the Wholesale Electricity Market (**WEM**) Rules.

Matter under Consultation

Clause 4.5.14B of the WEM Rules, which commenced on 1 June 2016, requires AEMO to develop a new Market Procedure to document the process that it follows when calculating the Expected DSM Dispatch Quantity and the DSM Activation Price.

Further details are provided in the Procedure Change Proposal and the proposed new Market Procedure published with this notice.

AEMO invites written submissions on this Procedure Change Proposal, including any alternative or additional proposals you consider may improve the procedure or better meet the Wholesale Market Objectives in section 122(2) of the *Electricity Industry Act 2004* (and clause 1.2.1 of the WEM Rules).

Please identify any parts of your submission that you wish to remain confidential, and explain why. AEMO may still publish that information if it does not consider it to be confidential, or otherwise as permitted by the WEM Rules, but will consult with you before doing so.

Meetings

In your submission, you may request a meeting with AEMO to discuss the Procedure Change Proposal. Please state why you consider a meeting is deemed necessary.

If appropriate, meetings may be held jointly with other Consulted Persons. Subject to confidentiality restrictions, AEMO will generally make details of matters discussed at a meeting available to other Consulted Persons, and may publish them.
