

## UPDATED CALL FOR SUBMISSIONS ON PROCEDURE CHANGE PROPOSAL

Wholesale Electricity Market Rules – Clause 2.10

# AEPC\_2018\_01: Monitoring and Reporting Protocol

Date of Notice: 10 December 2018

This notice informs all Rule Participants and interested parties (**Consulted Persons**) that, in accordance with clause 2.10.18 of the Wholesale Electricity Market Rules (WEM Rules), AEMO has published a notice of extension on the consultation for the Procedure Change Proposal in respect of the new Market Procedure: Monitoring and Reporting Protocol (**Procedure**).

This consultation is being conducted in accordance with the Procedure Change Process detailed in clause 2.10 of the WEM Rules.

## Matter under Consultation

The matters are related to clauses 2.15.6A and 2.15.6B of the WEM Rules which require AEMO to detail AEMO's processes for supporting the Economic Regulation Authority in monitoring Rule Participant compliance with the WEM Rules and Market Procedures.

Further details are provided in the notice of extension published with this notice. The proposed Procedure is published with this notice and the Notice of Extension.

## Invitation to Make Submissions

AEMO invites written submissions on this Procedure Change Proposal, including any alternatives or additional proposals you consider that may improve the Procedure or better meet the Wholesale Market Objectives in section 122(2) of the Electricity Industry Act 2004 (and clause 1.2.1 of the WEM Rules).



Please identify any parts of your submission that you wish to remain confidential, and explain why. AEMO may still publish that information if it does not consider it to be confidential, but will consult with you before doing so.

#### Meetings

In your submission, you may request a meeting with AEMO to discuss the Procedure Change Proposal, stating why you consider a meeting is necessary or desirable.

If appropriate, meetings may be held jointly with other Consulted Persons. Subject to confidentiality restrictions, AEMO will generally make details of matters discussed at a meeting available to other Consulted Persons, and may publish them.

Submissions in response to this Procedure Change Proposal must be emailed to wa@aemo.com.au, by 5.00 pm (AWST) on 10 January 2019.

All submissions must be forwarded in electronic format (both pdf and Word).
