Preliminary Matters

- 1. Attendees were noted and welcomed to the Program Consultative Forum (PCF).
- 2. The PCF confirmed the minutes of meeting number six held on 4 December 2018. The actions from meeting six have been reviewed and updated (see list below).

Matters for Noting

3. Program Update – G Windley (Slides 4-8)

AEMO presented a high-level transition plan for Dispatch and Bidding, Metering and Settlement systems. These included key milestones on procedure updates, the industry development schedule, AEMOs integration plan and the stakeholder engagement forums. The purpose is to show where participant plans fit into the industry schedule. AEMO requested feedback from participants, to update the transition plan for the following PCF.

AEMO noted that the 5MS program will be gradually transitioning to market readiness activities. More information on the high-level market readiness strategy will be presented at the coming PCF meetings.

Action 7.3.1: AEMO to present the 5MS high-level market readiness strategy in subsequent PCF meetings

4. Industry Risks & Issues – G. Windley (Slides 9-10)

The Industry Risk/Issue Register is available on the 5MS website here.

The current risks and issues were reviewed by members, and a number of minor changes proposed. An updated version of the register will be distributed with the meeting notes, and also updated on the 5MS website.

Stanwell raised concerns that any participant systems would also need to be considered if there are any unexpected procedural changes that affect IT systems. Stanwell also suggested that the Industry Risk/Issue Register should include risk ratings. AEMO agreed and include risk ratings from AEMOs perspective going forward.

Powershop requested further details on AEMO's engagement plan with small participants. AEMO noted that this plan was develop last year and is being refined over time. AEMO is currently working with Telstra on its engagement approach with small participants, and welcomes any further suggestions from the PCF.

AGL suggested that AEMO should increase engagement with the AEMC to consider the impact of any further Rule changes on scheduling and resourcing of the 5MS program.

Origin requested the date for Risk 06 be moved out to 30 June 2021, before the program go live.

AEMO proposed the addition of the issue surrounding AEMO support for participant programs in 2022, leading up to the 1 December 2022 mandatory go live for new and replacement meters.

Action 7.4.1: AEMO to assign risk ratings to risk items in the Industry Risk/Issue Register

5. Procedures Work Stream – E. Brodie (Slides 11-14)

AEMO noted that procedures work stream is progressing well, with formal consultations now well underway.

AEMO reiterated that pre-consultation activities including PWG engagement and circulation of High-Level Impact Assessments is intended as early engagement between AEMO and the 5MS working groups. Commencement of the formal consultation occurs when the Notice of Consultation is published on AEMO's website. Formal submissions to the consultation are required for feedback to be considered in the draft and final determinations.



AEMO reminded participants that submissions on the draft report for Metering Package 1 is due to close soon on 15 February 2019. First round consultation submissions on the 5MS Settlement Revisions Policy will be due 22 February.

The next PWG is scheduled for 14 February, with the Dispatch Focus Group to follow on 15 Feb. The Metering and Settlements Focus Groups are planned for February/March.

6. Systems Work Stream – Mal Borschman (Slides 23-28)

Overall the system workstream is in a good position, with required key resources in place. Dispatch, Settlements and Metering workstreams are tracking well. Vendor negotiations in the retail stream is in finalisation, with development work expected to start February 2019.

The next Systems Working Group is planned for Monday 18th February 2019.

Origin queried the current level of engagement with the industry on the Technical Specification documents, HLIAs on development packages and scheduling of market trials. AEMO noted that currently the Systems Working Group (SWG) is the main forum these discussions, however will consider the suggestion from Origin to engage more broadly with the industry.

Action 7.6.1: AEMO to discuss suggestions for engaging more broadly with the industry on technical documentation.

7. Stakeholder Update – C. Muffett

AEMO reminded participants that a dedicated 5MS web location to access 5MS specific consultations has been launched. This website provides a summary of key dates and materials for each work package. The actions log is also now online to coordinate issues and actions coming out of the 5MS program.

AEMO noted that it will be commencing a further round of 1 on 1 discussions with the industry. Fact sheets that provide further detail specific to participant roles are planned for development in March.

Currently AEMO is recruiting additional resources to support the stakeholder engagement activities.

Matters for Discussion

8. AEMO architecture for 5MS – Satheesh Kumar

AEMO presented an overview of the 5MS architecture. This included uplifts on system applications, integrations, data, infrastructure and security to meet the 5MS and GS rule change requirements.

The 5MS architecture will be presented again at the Systems Working Group on 18 February 2019.

9. Non-mandatory components – C. Muffett

AEMO noted that the 3 metering components are no longer considered as optional components in light of GS final determination – AEMO has outlined a proposed approach in



the draft determination for Metering package #1. Reallocation changes are being considered in light of feedback from Settlements Focus Group

AEMO reiterated that Energy Storage system changes are still under consideration, and only applies to grid scale batteries over 5MW. Hence it is distinct from the DER program.

New items that were included involve AEMO working with HydroTas to identify possible options and benefits of alternative settlement approaches to reduce impact on participant systems. AEMO is also working with Energy Queensland to identify possible options and benefits for AEMO to deliver more granular intermediate energy data, and possibly reduce the need for participants to independently perform profiling and reconciliation.

Action 7.9.1: PCF to provide feedback on level of interest in participating in workshop on reconciliation and profiling.


