1. Welcome, Introduction, Attendance and Apologies – P. Carruthers (slide 2-3)

AEMO noted that the meeting was being recorded for the purposes of preparing meeting notes and requested for dial-in attendees to email <u>5ms@aemo.com.au</u> for inclusion on the attendees list. The meeting notes for the previous PCF held on 17 July 2020 were confirmed.

2. Minutes and Actions from Previous Meeting – AM. McCague (slide 5)

The actions from meeting PCF #23 have been reviewed and updated. Please refer to the meeting pack.

3. Program Update – R. Leung, G. Windley, G. Minney (slides 8 - 13)

AEMO provided a program and milestone update and overview. It was noted that the overall AEMO 5MS Program is Green trending down.

The following milestones have been successfully completed:

- L2-RE22: Industry Transition Plan Dispatch final complete
- L2-M7: AEMO Internal Metering Solution Build Complete
- L1-13: AEMO Internal Development Complete
- L2-M8: Software Release 3 for Package 3 in 5MS Staging Environment

It was noted that a small number of non-critical residual build items will continue. These are internal AEMO items and do not impact the participant facing functionality or participant programs.

AEMO proposed to moved the Settlements deployment date from 1 April 2021 to 19 April 2021 as a mitigation measure for risk R28, as set out on slide 11.

Action 25.3.1: PCF to discuss proposed change in date to Settlements deployment with RWG members and provide AEMO feedback by 25 September 2020.

4. Executive Forum Debrief – P. Carruthers (slides 14 - 15)

A summary of the topics discussed at the Executive Forum on 30 July 2020 was provided.

5. Risks and Issues – AM. McCague (slides 16 - 19)

The proposed approach to issues as set out on slide 17 was agreed.



It was agreed that R02 should reference R19.

The proposed changes to R19 were agreed.

An update on R06 and R30 was provided and the Industry Risk and Issues Register will be updated to reflect the current position.

Action 25.5.1: AEMO to update the Industry Risks and Issues Register to reflect the decisions from PCF#25.

6. Readiness Workstream Update - G. Minney (slides 20 - 28)

AEMO provided a summary of the results of the third round of Readiness Reporting as set out in the slides.

It was noted that although there was an increase in the number of responses there was a decrease in number of participant roles. This is because some participants that had previously responded for their multiple functions did not respond for for all their roles in this round. AEMO is following up with these participants.

AEMO confirmed that the escalation process for the exceptions to the readiness reporting on essential capability was to discuss the issues that were preventing the participant or participants from meeting the criteria and understand the remediations possible. If resolution was not possible, AEMO would escalate this issue and consider whether the contigency actions should be triggered.

Action 25.6.1: AEMO to issue invitations to the Transition Focus Group by 10 September 2020.

Action 25.6.2: AEMO to confirm the update of Readiness Strategy documents to reflect changes due to the revised rule commencement dates and associated milestone updates

7. Systems Workstream Update – G. Windley (29 - 31)

AEMO provided an update on the systems workstream as described on slides 29 to 31.

It was confirmed that the Retail release in the 5MS Staging Environment would be set to 5-minute mode on 31 October 2020.

8. 5MS Cost Recovery – Kevin Ly (slide 32 - 34)

The approach to the review of AEMO's cost recovery structure was present as set out in slides 32 to 34.

9. Forward Meeting Plan (slide 35 – 38)

The agenda for the Vendor Briefing Session on 16 September 2020 was presented.

It was suggested that risks and issues relating to systems be included in the agenda.
