## 1. Welcome, Introduction, Attendance and Apologies - G. Minney (slide 1 - 4)

AEMO noted that the meeting was being recorded for the purposes of preparing meeting notes and requested for dial-in attendees to email 5ms@aemo.com.au for inclusion on the attendees list.

#### 2. Minutes and Actions from Previous Meeting – A. McCague (slide 5 - 6)

The actions from meeting RWG #21 have been reviewed and updated. Please refer to the meeting pack and list below for more details.

#### 3. 5MS Program Update - G. Minney (slide 7 - 10)

AEMO provided a status update on the 5MS Program timeline. Key points are noted on slide 8.

AEMO confirmed that participants will receive a notification on 8 April confirming whether the Retail solution will be deployed into pre-production by 19 April allowing Industry testing for Retail to commence as scheduled.

The checkpoint criteria that will be reported against at the PCF on 23 April were presented for information.

#### 4. Industry Readiness – G. Minney (slide 11 – 17)

Through slides 12 to 14, AEMO noted the changes in Readiness Report Round 6 since last discussed. These updates are because of further information being provided to AEMO through bilateral discussions with participants.

No changes to slide 12 since it was presented at RWG #21.

Rollout plans cover 99% of Tranche 1 meters. Currently, 30% of those meters are now 5 minute capable.

AEMO has discussed the rollout plans with several participants to understand the plans for meter activation and data delivery for Tranche 2 meters and will request data delivery rollout plans for Trache 1 as at 1 May.

Most of the rollouts for Tranche 2 will be from the third quarter of 2021. AEMO will continue to work with TFG to understand the volumes.

One Metering Service Provider noted that their schedule has minimum timeline contingency, and although confident of meeting compliance obligations, some MTP activity completion timings are "at risk". They are working on contingency plans to manage this risk.

AEMO provided clarity on how the Readiness survey should be interpreted to ensure the most accurate reporting of participant readiness.

A discussion took place on how the MSDR (MSATS Standing Data Review) Working Group and the 5MS Working Groups would be integrated to provide participants with an overall view.

Action 22.4.1: AEMO to provide clarity on how 5MS working groups will be updated on MSDR activities.

#### 5. Testing Update - T. Grant (18 - 21)

AEMO provided an update on the discussions that took place at the Industry Testing Working Group and Market Trial Focus Group, as set out on slide 19.

It was noted that the three Settlement runs in pre-production were run against the existing 30-minute Retail solution. Additional Settlement runs will be provided once the 5MS Retail solution has been deployed into pre-production. AEMO will be able to provide clarity on the timing of those runs by 16 April.

#### 6. Transition Focus Group / Metering Transition Plan Update – G. Minney (slide 21 – 28)



AEMO provided an overview of the TFG meeting held on 11 March 2021, a summary of the rollout plans, and upcoming MTP activities.

AEMO confirmed that they intend to streamline the quantifying factor across the TFG plans and will use meter rather than NMIS in templates for reporting.

**Action 22.6.1:** AEMO to confirm whether they intend to provide an extension to the deadline for cross-boundary meters as a result in the delay in publishing the guideline.

Action 22.6.2: AEMO to confirm is all NCONUML NMIs are to be provided to AEMO including the profile.

#### 7. Industry Risks and Issues Register - G. Minney (slide 33 – 39)

AEMO facilitated a review session of the existing risks, their current ratings and to consider their controls.

The following changes to the risks were agreed:

- R33 No change.
- R34 change as set out on slide 35 was agreed including updating the Residual Rating to "Significant"
- R21 No change in status. Actions as set out on slide 36 were agreed.
- R17 No change in status. Actions as set out on slide 37 were agreed.
- R04 change as set out on slide 37 was agreed including updating the Residual Rating to "Medium"
- R19 No change in status
- R02 a discussion took place on the value of this risk. The risk was added early in the 5MS Program
  before critical capability was defined. AEMO suggested that this risk has been superseded by R19
  and should be closed.
- R11 No change in status

**Action 22.7.1:** RWG to consider whether action R02 can be considered superseded by R19 and therefore can be closed.

**Action 22.7.2**: AEMO to consider incorporating the impact of increased CATS transaction volumes from initiatives such as MSDR into 5MS readiness risks.

## 8. Origin's proposed changes to GS Market Trial – F. Stuart (slide 40 – 42)

Origin presented their proposal to delay and reduce the length of GS Market Trial. The RWG was asked to consider this proposal and provide feedback to AEMO.

A question was raised about MSDR and MCPI and whether there would be a Market trail scheduled for either or both of those initiatives, as this may impact responses to the scope and timing of the GS Market trial

## 9. Retail / Metering Readiness – J. Agelopoulos (slide 43 – 47)

AEMO provided an update on the Retail workstream noting that an email will be sent on 8 April confirming is the deployment into pre-production and subsequent industry test period were progressing as scheduled.

AEMO noted that the Retail go-live plan cutover timings will be updated after the pre-production deployment is complete.

# 10. Dispatch / Bidding Update - I. Devaney (slide 48 - 51)

AEMO provided an update on the bidding and dispatch platform, noting that updates to the status and dates for deliverables have been highlighted on slide 50.



AEMO noted that the 5MS Bidding Service was live in production.

## 11. Settlements Update - M. Hillaby (slide 52 - 56)

AEMO provided an update on the Settlements workstream noting that the industry test period commenced as scheduled on 22 March.

AEMO provided an update on the Settlements Go-Live Plan, the feedback received to date and the subsequent changes that have been made to the document.

# 12. Forward Plan and Other Business – G. Minney (slide 57 - 62)

AEMO presented the proposed topics for the upcoming RWGs and ITWGs in 2021.

It was agreed that a separate session to discuss the Retail cutover plan would be scheduled and the Settlements cutover plan would be covered during the RWG meeting on 4 May.
