# AEMO Competition Law Meeting Protocol

AEMO is committed to complying with all applicable laws, including the Competition and Consumer Act 2010 (CCA). In any dealings with AEMO regarding proposed reforms or other initiatives, all participants agree to adhere to the CCA at all times and to comply with this Protocol. Participants must arrange for their representatives to be briefed on competition law risks and obligations.

#### Participants in AEMO discussions must:

- 1. Ensure that discussions are limited to the matters contemplated by the agenda for the discussion
- 2. Make independent and unilateral decisions about their commercial positions and approach in relation to the matters under discussion with AEMO
- 3. Immediately and clearly raise an objection with AEMO or the Chair of the meeting if a matter is discussed that the participant is concerned may give rise to competition law risks or a breach of this Protocol

Participants in AEMO meetings **must not** discuss or agree on the following topics:

- 1. Which customers they will supply or market to
- 2. The price or other terms at which Participants will supply
- 3. Bids or tenders, including the nature of a bid that a Participant intends to make or whether the Participant will participate in the bid
- 4. Which suppliers Participants will acquire from (or the price or other terms on which they acquire goods or services)
- 5. Refusing to supply a person or company access to any products, services or inputs they require

Under no circumstances must Participants share Competitively Sensitive Information. Competitively Sensitive Information means confidential information relating to a Participant which if disclosed to a competitor could affect its current or future commercial strategies, such as pricing information, customer terms and conditions, supply terms and conditions, sales, marketing or procurement strategies, product development, margins, costs, capacity or production planning.



#### MCPI/MSDR Update



- The third meeting of the MSDR Focus Group occurred on Tuesday 8 March
  - Discussion focused on determining the final data transition approach for MCPI/SIPF:
    - AEMO will defer its 'transitional' validations, relating to the SIPF field in CR5xxx transactions, until the end of the compliance holiday i.e. until 1 May 2023
    - LNSPs will initiate CR2xxx and CR5xxx transactions as required to accurately populate and maintain SIPF values from 1 May 2022
      - CR5xxx transactions to include any updates associated to verified shared fuse arrangements from 1 May 2022
    - LNSPs to use the Blind Update Tool (BUT) to perform mass updates to the SIPF field
      - AEMO is targeting the BUT to be available in Pre-prod by 23 May and Prod by 13 June
    - The BUT will be configured to:
      - Not allow the updating of an existing SIPF value in the MSATS database
      - Include BUT associated changes in the C1 reports
- MSATS Technical Specifications released Friday 11 March
  - Version 4.00 of the MSATS 47.1 Technical Specification (MSDR, MCPI, and GS)
    - Minor changes for the Blind Update tool only
  - Version 1.00 of the MSATS 47.2 Technical Specification (Blind Update Tool)
    - This version is for information only. The design is not ready for participant builds.
- The fourth meeting of the MSDR Focus Group occurred on Tuesday 22 March
  - Discussion focused on:
    - LNSPs SIPF standing data update plans
    - Initial consideration of MSDR data transition plan approach






