1 Welcome

AEMO provided an overview of the purpose and objective of the EWCF and advised that the EWCF will meet monthly with a focus on in-flight reforms, procedure development and consultations and other supporting material as part of delivering the NEM2025 program. AEMO advised that the NEM (National Electricity Markets) Wholesale Consultative forum is no longer being convened and added that the EWCF is not intended to take all the objectives of that forum.

AEMO provided a draft copy of the Terms of Reference (ToR) to members prior to the meeting and requested members to provide feedback ahead of the next meeting. AEMO briefed members on the propose EWCF engagement plan with a view to develop a roadmap for consultations to assist EWCF stakeholders with managing activities and resourcing.
