5 Retail Market Improvements (RMI)

- AEMO advised that development is underway and noted that details for the industry test strategy will be shared at the June ITWG meeting. AEMO outlined the industry test windows and are available on slide 16 of the accompanying slide pack. It was noted that the industry test for the NSLP changes will follow the approach taken for 5MLP last year and Settlements will not be in scope for this test.
- In addition, production deployment for both ICFs will be scheduled for 29 September 2024. AEMO noted that the September Technical Specification¹ has been drafted.

6 Frequency Performance Payments (FPP – NFO)

AEMO noted that development is in progress and due for completion by the end of June 2024. Further
