6.1 Changes in scope and timing

 AEMO recapped the update previously provided to the May 2023 RDC meeting on the Operational Security Mechanism. The AEMC confirmed a directions paper is expected by the last week of August 2023 or first week of September 2023. The change assessment is outlined on slide 21 of the accompanying slide pack.

Data Services

An update was provided on Data Services with key information outlined on slide 22 of the

Congestion Relief Market & Priority Access Model

Scheduled Lite

 An updated was provided and it was advised that a rule change consultation process is yet to commence. The AEMC confirmed a consultation paper is to be published 3 August 2023. Further information is outlined on slide 26 of the accompanying slide pack.

SCADA Lite

• It was advised that implementation of SCADA lite is yet to commence. AEMO is progressing through the final stages of planning and governance preparation. AEMO noted that Go-Live for SCADA lite is anticipated for March 2024. A Committee member asked how realistic this timing is in light of the current intensity of development across NEM Reform. AEMO to follow-up. Further information is outlined on slide 27 of the accompanying slide pack.

DOE, Data Hub & Registry Services, DER Operational Tools, DLNS

 AEMO advised that policy development and design for these initiatives remains ongoing and a clear direction on scope and timing of these initiatives will be subject to several processes. Additional information is available on slide 28 of the accompanying slide pack.

Greg Hannan - CitiPower/Powercor/United Energy	While the Roadmap captures several initiatives that are progressing albeit at a slow burn, other mandates / initiatives are coming down the pipeline, particularly at a jurisdictional level, with greater certainty and with similar IT system or business process impacts to participants (and potentially AEMO). To what extent, do we need to account for these and what level of interdependency exists among all initiatives.	AEMO to review jurisdictional DER initiatives and identify both commonality with those initiatives on the Roadmap and potential IT system or business process impacts and whether some coordinated industry action makes sense or not. AEMO to report back ahead of the next RDC meeting.

Bill Transparency

AEMO advised that a consultation paper was issued by the ESB in June 2023 and that policy
development and design phase remains ongoing. AEMO advised the AEMC would be leading this
consultation process following the transition from the ESB, with submissions to the consultation paper
due in September 2023. Further information is outlined on slide 29 of the accompanying slide pack.

Network Visibility

AEMO advised that a consultation paper was issued by the ESB in June 2023 and that policy
development and design phase remains ongoing. AEMO advised the AER would be leading this
consultation process following the transition from the ESB, with submissions to the consultation paper
due in September 2023. Further information is outlined on slide 30 of the accompanying slide pack.

Electric Vehicles Charging Standing Data Registry

AEMO advised that the ESB published its Consultation Outcomes Report in June 2023 outlining its
key recommendations including for AEMO to develop a rule change request for the AEMC's
consideration to expand the DERR to include EVSE data. AEMO advised it was working on a rule



change proposal to be submitted towards the end of calendar year 2023. Further information is outlined on slide 31 of the accompanying slide pack.
