Proposed Changes to the ERCF Change Process

Proposed Changes to the Issue/Change Form (ICF) Template

- AEMO has reviewed the ICF template to ensure it effectively supports the ERCF Change Process
- One of the key considerations of the review was the Proponent's ability to provide requested information at a suitable standard
- As a result of the review, AEMO is proposing for the template to now include the following items:
 - A detailed understanding of the Issue/change being requested, including:
 - How long the issue has existed e.g. recently discovered/introduced, 1-2yrs, 2-5yrs, 5+yrs
 - A detailed understanding of the impact on their organisation
 - Quantification of the impact on their organisation
 - Any workarounds which they have implemented to manage the issue
 - What Participant engagement has occurred to date
 - Who and what feedback they have received
 - An initial high-level AEMO and Industry impact assessment
 - e.g. High impact, the issue is likely having a significant impact on multiple Participants
 - The likely benefits and impacts to AEMO, Participants and/or customers associated to the resolution of this issue
 - Any critical timelines or Rules which should be considered
 - An initial description of any proposed changes
- Note, if a Proponent does not provide the above information, AEMO will return the ICF to the Proponent for further drafting

AEMO/Industry Initiated Change Cycles

- Context
 - Participants have voiced their concerns regarding the amount of change they have had to accommodate in recent years i.e. 'change fatigue'
 - AEMO recognises the amount of regulatory change which has been approved, or which is in train, which will continue to impact AEMO and Industry over the coming years
- Proposal
 - AEMO is proposing to limit AEMO/Industry initiated change implementations to twice per year
 - Noting that the current ERCF Change Process only allows for annual prioritisation, section 2.7:
 - "Each year, AEMO will table a proposed prioritisation strategy and a list of initiatives from the Change Log with the ERCF for consideration."
- AEMO acknowledges that certain changes i.e. to support new Rule requirements may need to occur outside of these designated cycles
- Change cycle allocation considerations
 - Consultation requirements/timings
 - Other changes happening in the Industry in parallel
 - AEMO and Industry system/process implementation timelines
- Feedback being sought
 - \(\) Is the ERCF supportive of this approach?
 - When should the 2 cycles occur, being conscious of summer peaks and Dec/Jan 'shutdowns'?

AEMO/Industry Initiated Change Cycles

- Hypothetical timings, assumes the consultation needs to comply with NER 8.9 Rules Consultation Procedures i.e. 2 full consultations:
 - Proposed change effective/implementation date: Nov 2022
 - Consultation commencement: by 31 March 2022
 - Final Determination published: by 31 July 2022
 - Proposed change effective/implementation date: 1 April 2023
 - Attempting to shift the Final Determinations to pre-Dec/Jan breaks
 - Consultation commencement: by 15 August 2022
 - Final Determination published: by 15 December 2023
 - Proposed change effective/implementation date: 1 Oct 2023
 - Consultation commencement: by 31 February 2022
 - Final Determination published: by 31 June 2022
- AEMO would endeavour to include any minor amendment consolidation consultations into these cycles
- For easy reference: NER 8.9 Rules Consultation Procedures:
 - Initial Notice published
 - Submissions close: not to be less than 25 business days
 - Draft Report published: not more than a further 20 business days
 - Submissions to the Draft close: not to be less than 10 business days
 - A Final Determination published: not more than a further 30 business days

Incorrect Assignment of the MC Update

Proponent - Helen Vassos (PlusES)

- Issue/Change:
 - Incorrectly nominated MCs need to request another party (either the FRMP or the correct MC) to initiate a transaction in MSATS to resolve the incorrect assignment of the MC role.
- Impact:
 - The request to correct the MC role is done manually and via email which impacts FTE requirements.
- Participant engagement to date
 - Raised at ERCF on 24 November 2021
- Proposed solution
 - For the RPERR3 report to be sent to participants who are able to directly make the required correction.
- Potential solution benefits and impacts
 - Benefits: Reduction of FTE effort for the incorrectly nominated MC.
 - Impacts: Increased FTE requirement for the resolving party.
- Status/update
 - Dino/Helen to provide an update at the meeting
