

- This GMI relates to detection and proposed remediation of inconsistent determination/population of 'Meter Status' in an MDN transaction across East Coast Gas markets and Western Australia
- This GMI specifically proposes:
 - 1. All East Coast Gas and Western Australian Gas Retail Market Participants adopt population of the Meter Status in an MDN Transaction as per Approach A in the GMI. i.e.
 - <u>Where an MDN is provided, the Allowed Value populated in 'Meter_Status' field must reflect the status of the meter that was effective</u> As At the date and time the associated Meter Read was taken and/or attempted to be taken.
 - In the case of an MDN taken as part of a De-Energisation, the Meter Status should reflect the status after the successful Deenergisation.

In the case of an MDN taken as part of a Re-Energisation, the Meter Status should reflect the status after the successful Reenergisation.

- 2. AEMO Build Packs to be updated in all instances a MDN transaction OR Meter Status is referenced
- A GRCF Questionnaire and updated GMI distributed to GRCF on 2nd April 2024. Updated GMI resent on the 8th April 2024. GRCF feedback requested by the 15th April.

- AEMO received x9 GRCF responses to 'Questionnaire: GMI IN002-24 Resolve issue with Meter Status in MDN'.
 - x1 GRCF response indicated no response to Questionnaire would be provided (Shell)
 - x1 GRCF response indicated further time required to complete analysis/questionnaire (AGN)
- In summary, across x7 GRCF responses:
 - Majority general support for the GMI proposal except for x1 GRCF response (MGN)
 - Majority general support for Approach A except for x1 GRCF response (MGN)
 - Varying support in how Approach A should be represented in AEMO artefacts:
 - x1 GRCF response supported Option 1 (EA)
 - x1 GRCF response supported Option 2 (Red/Lumo)
 - x4 GRCF responses supported Option 3 (Synergy, GloBird, Alinta, Jemena)
 - x1 GRCF response supported no Option (MGN)
 - General support for proposed explanatory note with additional wording proposed (Jemena) to cover abolishment / meter removal scenarios and consideration to proposed change to apply from an effective date
 - Little/no system change impacts with the exception of x2 GRCF responses indicating high system impacts (Jemena & MGN) and x1 GRCF response indicating no capacity to implement changes in 2024 (MGN)






