2. Procedure Change Proposal for Market Procedure - Certification of Reserve Capacity

• Question – What is the definition of Business Days and the applicable time zone in the Procedure?

Answer – Clause 1.4.3 of the WEM Rules stipulates that the WEM operates on Western Standard Time (Coordinated Universal Time (UTC) plus 8 hours). The WEM Rule defines Business Days as particular to Western Australia.

• Question – What is the hierarchy of Procedures to the WEM Rules?

Answer – Step 1.2.1 of the Procedure indicates that to the extent that this Procedure is inconsistent with the WEM Rules, the WEM Rules prevail to the extent of the inconsistency (clause 1.5.3 of the WEM Rules).

• Question – Why is "Sent Out Capacity" defined in the Procedure?

Answer (question taken on notice during the meeting and response now provided) – AEMO will remove the definition from the Procedure and rely on the defined term in the WEM Rules.

• Question – Step 2.1.3, regarding modification of timings, applies to many aspects, not just submission of applications. Why is this step in section 2.1?

Answer (question taken on notice during the meeting and response now provided) – AEMO will move step 2.1.3 to a new section.

• Question – In step 3.5.3, why was 15 Business Days reduced to ten?

Answer (question taken on notice during the meeting and response now provided) – AEMO will revert to the 15 Business Days stipulated in the existing Procedure.

• Question – What decision is referred to in step 3.5.5, as step 3.5.1 does not appear to contain a decision?

Answer (question taken on notice during the meeting and response now provided) – AEMO will amend the relevant steps to provide clarity.

• Question – Why were steps 4.3.2 and 4.3.3 from the existing Procedure removed?

Answer (question taken on notice during the meeting and response now provided) – AEMO has reviewed the existing Procedure and has determined the following:

- Step 4.3.2 of the existing Procedure covers items not otherwise captured by the proposed step 4.3.1, so AEMO will add it back into the Procedure.
- Step 4.3.3 of the existing Procedure has been amalgamated into the proposed step 4.3.1.
- Steps 4.3.4 and 4.3.5 of the existing Procedure are no longer relevant due to the removal of clause 4.10.2 of the WEM Rules.
- Step 4.3.6 of the existing Procedure is not required given the proposed changes to step 4.3.1 and the retention of step 4.3.2.
