1. Welcome

AEMO presented the high-level plan for revision of the Power System Operation Procedures. This presentation is available on AEMO's website in the meeting pack for the WAECF meeting on Thursday 14 December 2017.

2. Procedure Change Proposal for Monitoring and Reporting Protocol

 Question – Step 1.5.3: Should the wording here be more specific – i.e. should this section specify a list of sources and tools that AEMO may use?

Answer – The clause is not specific as it needs to capture the fact that there is a vast array of sources/tools which AEMO uses in its everyday operations that may pick up non-compliant participant behaviour, rather than any one tool. It is also dynamic and changing so to list out all tools and sources would be non-exhaustive and potentially limiting. AEMO welcomes any specific suggestions on this matter.

3. Procedure Change Proposal for PSOP: Tolerance Range

Question – What is looked at practically in determining tolerance ranges? For example, if a new staff
member were to be given the procedure it would be difficult for that person to undertake a practical
application of the procedure.

Answer – The Procedure details obligations at the highest level. AEMO analyses many factors in reviewing and determining the Tolerance Range, including the items detailed in step 2.2.1. The importance of variables can change from year to year.

 Question – Step 2.2.1(d): Should the wording here be more specific – i.e. how will other Rule Participants be able to assess whether or not the set of "any other circumstances and information which AEMO considers reasonable" is appropriate?

Answer – The Procedure needs to allow for flexibility, and for items that are not foreseen. Rule Participants will be able to assess any of these factors through the Tolerance Range consultation process if AEMO determines that the methodology for determining the Tolerance Range needs to be modified.

- Question Step 2.2.1: what is the objective of the Tolerance Range review? Can it be "a reasonable balance of compliance and impacts on Power System Security"?
 - Answer The WEM Rules indicate the use of the Tolerance Range. It is difficult to specify an objective for the review that does not limit the outcomes, however AEMO welcomes any specific suggestions on this matter.
- Question Step 2.3.1(b): Why is this limited to small generators?
 - Answer Wording will be modified to include generators of any capacity.
- Question Step 2.3.1(c): Is the wording "excessively variable" appropriate given that it could apply to generators that are capable of rapidly varying their output to respond to changing system conditions i.e. not just to generators that have inherently volatile output?
 - Answer Wording will be modified to include generators of any ramping capability.
- Question Step 2.3.1(d): Should the wording here be more specific i.e. how will other Rule Participants be able to assess whether or not the set of "any other circumstances which AEMO considers reasonable" is appropriate?
 - Answer The Procedure needs to allow for flexibility, and for items that are not foreseen. Rule Participants will be able to assess any of these factors through the Tolerance Range consultation process if AEMO determines that the methodology for determining the Tolerance Range needs to be modified.
