1. Welcome and attendance / apologies – Hugh Ridgway, AEMO

Hugh Ridgway (AEMO) welcomed all to the meeting.

2. AEMO Competition Law Protocol – Hugh Ridgway, AEMO

The GWCF noted AEMO's Competition Law Protocol and its requirements on both AEMO and participants.

3. Confirm agenda and previous meeting minutes and actions – Hugh Ridgway, AEMO

The GWCF confirmed the agenda.

The GWCF confirmed the previous meeting minutes as accurate.

4. AER Update – Jeremy Llewellyn, AER

Jeremy Llewellyn (AER) spoke to a compliance report for the facilitated gas markets.

5. AEMC Update – Meredith Mayes, AEMC

Meredith Mayes (AEMC) noted that the AEMC's main work program pertaining to gas is the [Review of the Gas Supply Guarantee](#). Meredith noted that the AEMC was endeavouring to publish the draft report by the end of July. Meredith invited any GWCF participant who wished to discuss the report with the AEMC to contact Daniela Moraes (AEMC) (daniela.moraes@aemc.gov.au).

6. Gas Market Monitoring Markets Update – Darryl White (AEMO)

Darryl White (AEMO) provided the 2021 Autumn Update to the GWCF.

7. Gas Market Monitoring General Update – Robbie Flood (AEMO)

Robbie Flood (AEMO) spoke to the slides regarding the general update from the Gas Market Monitoring team. Robbie noted that AEMO would begin a consultation on the Capacity Trading

and Auction Procedures on 14 July 2021, with an expected effective date of 4 November 2021.

8. Upcoming Transportation Service Point Register Consultation – Robbie Flood (AEMO)

Robbie Flood (AEMO) noted that AEMO would soon be consulting on the Transportation Service Point Register to effect some minor changes for the EGP and SWQP.

9. Overview of Feedback to Distributed Gas Resources (Hydrogen and Biogas) Paper – Yvonne Tan (AEMO)

Yvonne Tan (AEMO) provided an overview of the feedback AEMO received to the Distributed Gas Resources (Hydrogen and Biogas) paper.

Beck Mason (APA Group) asked what AEMO's next steps would be. Yvonne Tan (AEMO) responded that AEMO would bring the next steps regarding distributed gas resources to the GWCF when it had a firmer timeline for effecting the changes.

David Headberry (Major Energy Users' Association) noted that the Victorian government was investigating the possibility of employing contingency gas in the DWGM as it is employed in the STTM and asked whether AEMO had begun any work programs with respect to this matter. Hugh Ridgway (AEMO) noted that AEMO would take an action to respond to this by the next GWCF (**Action item 31.9.1**).

10. Other Business

Beck Mason (APA Group) noted that the consultation on the VTS Access Arrangements is underway and asked that any GWCF participant with feedback to that consultation contact Scott Young (APA Group).
